A. Personal Statement

I have been a member of the faculty of the Division of Endocrinology at the University of Pittsburgh since 1989, where I have been continuously involved in clinical diabetes research that investigates contributors to insulin resistance in individuals with or at risk for type 2 diabetes as well as a focus on interventions that help to improve glycemic and metabolic control in patients with types 1 and 2 diabetes. I was a co-investigator in several large clinical trials related to diabetes care, including the *Bypass Angioplasty Revascularization Investigation in type 2 diabetes (BARI 2D)* and the Look AHEAD Study, a multicenter randomized clinical trial that examines the ability of a long term lifestyle intervention program in overweight and obese individuals with type 2 diabetes to influence cardiovascular outcomes.
